Subject: Charges Fee for Debt Collection, Enforcement and Litigation

To update the Charge Fees for Debt Collection, Enforcement and Litigation to be complied with the current law, the Charges Fee for Debt Collection, Enforcement and Litigation shall be the following lists and rates as specified in the below table (Repeal Directive No. Sor.Kor. 042/2021 Subject: Charges Fee for Debt Collection, Enforcement and Litigation)
